Office Order

Block Project Manager, Motipur, Muzaffarpur sent a mail dated 21.08.2014 reporting therein about the excess withdrawal of ICF money (Rs. 30000/-) from three SHGs in village Pasouniya, cluster Bariyarpur, Motipur by Ms. Shikha Bharti, Community Coordinator. In order to verify / examine the alledged irregularities committed by Ms. Shikha Bharti, CC, Mr. Uday Kumar Verma, State Finance Manager visited Motipur block and submitted a report after examination of the documents related to fraudulent withdrawals of money from SHG account. In his report, dated 13.09.2014, Sri Verma confirmed that Ms. Shikha Bharti, CC got blank Withdrawals Forms signed by the authorized signatories of the bank accounts of SHG and withdrew Rs. 40,000/- from the bank account of all 3 SHGs each on 20.04.14 & 28.04.14 and handed over Rs. 30,000/- only to each respective SHGs keeping the balance amount totalling to Rs. 30,000/- with her and utilized the same for her personal purposes.

Based on the report of Mr. Uday Kumar Verma, SFM, a showcause notice, dated 27.09.2014 was issued to Ms. Shikha Bharti to which she submitted her reply, dated 08.10.2014. In her reply, Ms. Shikha has accepted that she had withdrawn the money for her personal exigency.

Earlier a show-cause notice dated – 23.07.2014 had also been issued to Ms. Shikha Bharti by BPM, BPIU – Motipur regarding her unauthorised absence from duty. In spite of that, as per e-mail dated 06.11.2015 of BPM- Motipur sent to DPM, Muzaffarpur, Ms. Shikha Bharti has been absent from her duty since 03.06.2014 till date without furnishing any information in this regard.

In addition to above, as reported by DPM vide his mail dated 06.11.2015, a complaint against Ms. Shikha Bharti, CC regarding financial irregularity of about Rs. 99,600/- (Ninety nine thousand and six hundred only) has also been received from BPIU – Mushahri, Muzaffarpur.

Thus, It is evident that Ms. Shikha Bharti, CC has misappropriated the funds of CBOs as well as project, dishonestly. She is guilty of fraud & leaving work place during duty period, without permission of Competent Authority. Hence, Ms. Shikha Bharti has committed grave misconduct as mentioned in para (b) 1, 12 and 15 & (a) 2 of annexure 6 of HRD Manual of BRLPS.

Therefore, In view of the above facts, Ms. Shikha Bharti, CC, BPIU – Motipur, Muzaffarpur is hereby terminated from the services of BRLPS with immediate effect.
